To Our Customers:

At Xenith, we are committed to the athlete through development of innovative products and hold ourselves to the highest standards of excellence and performance in the industry.

Following a customer inquiry in late 2015, we began investigating if the polycarbonate shell of certain gloss or metallic-painted helmets could unexpectedly crack. We reviewed internal test and manufacturing protocols. We also retained an independent laboratory to perform additional testing and analysis from an external point of view.

The review identified the issue: a "flex" additive chemical compound, which prevents other coating components from causing embrittlement of the shell material, was not included in the paint mixture for gloss and metallic painted helmets from May 2015 through March 2016.

We have since corrected this issue and implemented a solution so that all gloss or metallic-painted helmets manufactured since March 2016 include the "flex" additive chemical compound.

To meet the highest standards of excellence and performance for our products, we made the decision to announce a voluntary recall of Xenith Epic Varsity, X2 Varsity, X2E Varsity and Youth football helmets with a gloss or metallic-painted polycarbonate shell sold or factory reconditioned from May 2015 through March 2016. This recall was announced in close coordination with the U.S. Consumer Product Safety Commission (CPSC) on Wednesday, August, 17, 2016.

Fortunately, there have been no reported injuries related to this issue.

Our focus now is working with our customers to replace helmets included in the recall with new helmets – at no cost to them and as quickly as possible.

We apologize for the inconvenience this causes our customers. We recognize the trust players, parents and coaches place in us to provide high-quality and innovative products, and we will continue to work hard every day to earn that trust.

#### **Questions and Answers**

## Why is the voluntary recall taking place?

The shells of certain gloss or metallic painted football helmets could crack, posing a potential head injury hazard to the user. However, no injuries have been reported. Xenith is taking this voluntary corrective action in close coordination with the Consumer Product Safety Commission (CPSC) to ensure our products continue to meet the highest standards of excellence and performance. Fortunately, there have been no reported injuries related to this issue.

### What football helmets are being voluntarily recalled?

Only Xenith Epic Varsity, X2 Varsity, X2E Varsity and Youth football helmets with a gloss or metallic-painted polycarbonate shell sold or factory reconditioned from May 2015 through March 2016 are included in this recall.

- Injected color shells and matte painted shells are *not* included.
- Gloss or metallic painted polycarbonate helmets sold before or after May 2015 to March 2016 are not included.
- Football helmets reconditioned and painted by others (not Xenith) are not included.
- No other Xenith products are affected.

### How did this happen?

### How do I determine if my helmets are included in the recall?

If a football helmet is included in the voluntary recall, the teams and players should stop using them. Xenith will arrange for shipping, replacement and return of the helmets, at no charge.

We apologize for the inconvenience this causes our customers and are committed to working with you to get new helmets to your teams as quickly as possible.

## How long will the whole process take?

It will take approximately 8-10 business days. We are committed to delivery of new helmets as quickly as possible. If a helmet is needed sooner, Xenith will work to deliver a replacement helmet as soon as possible.





### Why are you sharing this information now?

We worked closely with the Consumer Product Safety Commission (CPSC) as part of this in-depth investigation and review process.

We have also been working in close coordination with the CPSC in accordance with its recall protocol and we were not able disclose the information in advance of the voluntary recall in conjunction with the CPSC. Upon CPSC approval, Xenith announced the voluntary recall.

# Are Xenith helmets safe? How can you ensure that?

Xenith is committed to meeting the highest standards of excellence and performance for our products. As part of our ongoing quality assurance process, we regularly test all of our products to ensure they meet the standards for certification set by the National Operating Committee on Standards for Athletic Equipment (NOCSAE), an independent research organization dedicated to creating performance standards for protective equipment in the U.S.

Xenith is the recognized industry leader in helmet technology and is the only manufacturer to exclusively produce Five-Star helmets under the widely accepted Virginia Tech rating system. Xenith football helmets feature Xenith Adaptive Head Protection® - a system of patented technologies designed to provide superior fit and to help minimize the sudden movement of the head during impact. Hundreds of thousands of players at all levels, including youth, high school, major college and the NFL wear Xenith helmets.

The Xenith EPIC Varsity Football Helmet is designed for players in high school, college and professional levels. The helmet ranked #1 in testing published with the 2015 NFL Health & Safety Report and is rated 5 STARS by the Virginia Tech Helmet Ratings<sup>™</sup>. Xenith X2E Varsity was also rated 5-STARS by the Virginia Tech Helmet Ratings<sup>™</sup>.

It is important to note there have been no reported injuries associated with the voluntarily recalled shells. We recognize the trust players, parents, and coaches place in us to provide high-quality and innovative products, and we will continue to work hard every day to earn that trust.

# **Recall Summary**

Name of Product: Football helmets

**Hazard:** The shells of the football helmets could crack, posing a head injury hazard to the user.

**Remedy:** Replace

Football players should immediately stop using the recalled helmets. Football players, coaches and parents should contact Xenith to receive a free new replacement helmet.

# **Recall Details**

Units: About 5,900

**Description:** This recall involves Xenith Epic Varsity, X2 Varsity, X2E Varsity and Youth football helmets with a gloss or metallic-painted polycarbonate shell sold or factory-reconditioned between May 1, 2015 and March 18, 2016. The helmets were sold in multiple sizes depending on the model, and in varying colors and custom-paint designs. They have a facemask and a chin cup, available in different styles and varying colors, and may have an optional eye shield. The serial number is printed on a white sticker inside the top of the helmet. **Incidents/Injuries:** The firm received 29 reports of cracking helmets; no injuries reported.

**Sold at**: Through team dealers and direct school sales, and at BSN, Buddy's All Stars, Carey's Sporting Goods, End Zone Sports and Sports, Inc. and other stores nationwide and online at Eastbay.com, Footlocker.com, SafetyFirstSports.com, SportsUnlimitedInc.com and Xenith.com from May 2015 through March 2016 for between \$140 and \$400.
