SEI Certification Bulletin #14 – Additional Contract Test Laboratory

This bulletin will serve as an announcement to SEI NOCSAE Participants regarding the acceptance of an additional contract test laboratory for the NOCSAE Certification Program.

<u>Introduction of an additional contract test laboratory for the SEI NOCSAE Certification</u> Program

SEI is pleased to announce that it has entered into an agreement with Chesapeake Testing Services Inc. (Chesapeake Testing), recently acquired by National Technical Systems Inc. (NTS), to conduct SEI NOCSAE certification program testing. This includes testing to all of the current NOCSAE standards. SEI is confident that the signing of the agreement will initiate a long term relationship, benefiting both SEI participants as well as consumers. Chesapeake Testing, located in Belcamp, Maryland, is accredited as an ISO/IEC 17025 laboratory by the American Association for Laboratory Accreditation (A2LA) with a broad scope covering (amongst other products) NOCSAE standards.

Given that SEI currently utilizes ICS Laboratories, Intertek, and Southern Impact Research Center (SIRC) for SEI NOCSAE testing, the addition of Chesapeake Testing will allow an additional laboratory option for both initial and annual NOCSAE submittals. Participants shall identify in the description box on the SEI Submittal Form as to which of the four (4) contract test laboratories they wish to utilize for testing.
